## INQUBOMGOMO YEZIVIKELO ZOKUHWEBA

Le NqubomgomO isebeNzisa amatemu amaningana achaziwe, aqala ngosonhlamvukazi uma esetshenziswa. IzincazelO zibekwe ngokucacile kusigaba 6, ekupheleNi kwale NqubomgomO.

### 1. Isingeniso

Abaqondisi nabasebenzi bayakhuthazwa ukuba babe ngabanikazimasheya akwa-Brambles besikhathi eside. Njengoba i-Brambles ingaphansi kwe-ASX (okuchaza ukuthi amasheya ayo umphakathi uhweba ngawo khona), kubalulekile, nokho, ukuthi kuqikelelwE esikhathini sanoma yikuphi Ukusebenza ngamasheya akwa-Brambles noma amanyE ama-Brambles Securities.

Le dokhumenyi ibeka ngokucacile inqubomgomO yakwa-Brambles mayelana Nokusebenza ngama-Brambles Securities kanye nakuwo ama-Securities ezinye izinkampani "Ngabantu Abajutshiwe". InhlosO Yale NqubomgomO yilokhu:

- (a) ukulekelela labo bantu ukuze kugwenywe ukuziphatha okwaziwa ngokuthi yi- "insider trading" (noma i- "insider dealing"); kanye
- (b) nokuvikela abakwa-Brambles ezinkulumweni ezingabalimaza ezenziwayo zokuthi izikhulu zabo eziphethe kanye nabasebenzi kungenzeka ukuthi ziye zazibandakanya ezenzweni ezingekho emthethweni, noma zenze ngendlela yokuzihlomulisa zona zisebenzisa ulwazi olungatholakali emphakathini.

Ngenxa yalezi zizathu, le NqubomgomO ngandlela thile yelula izimfuno zeZomthetho e-Australia.

Le NqubomgomO ibandakanya:

- (a) imithetho okufanele ilandelwe Abantu Abajutshiwe abafisa Ukuhweba ngama-Brambles Securities, kubandakanya nenqubo eyimpoqo yokugunyazwa kwangaphambilini;
- (b) ukuvinjelwa Ukuhweba ngama-Securities kwenye inkampani ngaBantu Abajutshiwe lapho lowo Muntu Ojutshiwe enolwazi olubucayi ngamanani aleyo nkampani ngokuvamile angatholakali; kanye
- (c) nesifingqo esifishanyana somthetho ngokuhlobene nomhwebi wangaphakathi e-Australia. Lesi sifingqo asihlosiwe njengesitativende esiphelele somthetho kule ndawo, futhi sihlinzekwe njengendlela eyisendlalelo kuphela.

### 2. Imithetho yokuhweba kuma-Brambles Securities

#### 2.1 Abantu Abajutshiwe

Le NqubomgomO isebeNzisa kulaba bantu abalandayo:

- (a) Abaqondisi neNhloko Yophiko LwezoMthetho noNobhala WeQembu Lenkampani;
- (b) noma yimuphi umuntu oseyekile ukuba Umqondisi Ophezulu kodwa oselokhu engumsebenzi

weQembu;

- (c) amalungu ethimba Lobuholi Obuphezulu bakwa-Brambles nalabo ababika ngqo kubona;
- (d) bonke abasebenzi abaqqashwe ngaphansi kwendima ka-Band 4 (abasebenzi abasezingeni lobuqondisi) noma ngaphezulu;
- (e) bonke abasebenzi abatholakala Ekomkhulu lakwa-Brambles eLondon noma e-Sydney;
- (f) nanoma yimuphi omunye umuntu owazisiwe ukuthi ungaphansi kwale Nqubomgomo yisiKhulu EsiyiNhloko sakwa-Brambles noma ilungu elifanele leThimba Lobuholi obuPhezulu, noma iNhloko YezoMthetho Nonobhala weQembu leNkampani; kanye.
- (g) ngokuhlobene nanoma yimuphi umuntu ongaphansi kuka (a) kuya ku-(f) ngenhla, kodwa ngaphansi kwendima 2.7:
  - (i) umlingane ashade naye;
  - (ii) noma yiziphi zezingane zabo (kubandakanya nabasinga-bantwana), abangaphansi kweminyaka eyi-18 ubudala;
  - (iii) abaqqokwe yibo, kubandakanya imenenja yezotshalomali nabalawula izimali egameni labo;
  - (iv) i-trust bona, noma yiliphi ilungu lomndeni wabo, noma eyiphi inkampani elawulwa umndeni, abangama-trustee noma abahlomuli kuyona;
  - (v) umuntu osebuldelwaneni bebhizinisi nabo noma nayibaphi abantu babo ababalwe ku(i) kuya ku(iii) ngenhla (ome esikhundleni sakhe); kanye
- (vi) inkampani bona noma umndeni wabo oyilawulayo. Laba bantu babizwa kule Nqubomgomo

### **Njengabantu Abajutshiwe.**

Amagama namakheli Abantu Abajutshiwe azohlinzekwa kurejistri yamasheya akwa-Brambles ekuhambeni kwesikhathi, ngezizathu zokuphenya ukulandelwa komthetho ngale Nqubomgomo kanye nokuvnjwa kokuhweba kwabantu abangaphakathi.

### **2.2 Imithetho Ejwayelekile**

Abantu Abajutshiwe akufanele bahwebe kuma-Brambles Securities uma benolwazi olubucayi lwamanani malungana ne-Brambles ngokuvamile olungatholakali emakethe. (Izimo zokunquma lapho ulwazi ngokujayelekile lutholakala zichaziwe kundima yokugcina yesigaba 5.1 sale Nqubomgomo.)

Abantu Abajutshiwe ngeke banikeze imvume yokuHweba ngama-Brambles Securities ngaphansi kwasigaba 3 sale Nqubomgomo lapho ulwazi olubucayi lutholakala khona malungana nodaba ngokuvamile olungatholakali, ngisho noma bazi ngalo.

Abantu Abajutshiwe akufanele bazibandakanye kuwo umkhuba wokutshela abantu ulwazi oluyimfihlo (bheka kundima 5.1(b)(iii) ngezansi) malungana nama-Brambles Securities, noma ama-securities anoma yiliphi ibhizinisi, nganoma yisiphi isikhathi.

### **2.3 Akukhona ukuhweba okwesikhashana kuma-Brambles Securities**

Abantu Abajutshiwe akufanele bazibandakanye ekuhwebeni kwesikhashana noma okusolisayo kuma-

Brambles Securities. Kufanele babambele kuma-Brambles Securities isikhathi esingengaphansi kwezinsuku ezingama-30. Lokhu akubhekisile kunoma yikuphi ukudayisa kwe-Brambles Securities okunikezwe ngenxa Yemiklomelo enikezwa esikhathini sezinsuku ezingama-30 lapho imvume yokudayisa ngaphansi kwesigaba 3 sale Nqubomgommo seyitholakele.

## **2.4 Ama-derivatives**

Abantu Abajutshiwe akufanele bahwebe ngama-Derivative akwa-Brambles.

Lokhu kuqondise kuma-Brambles Securities anemiklomelo. Kuchaza ukuthi Abantu Abajutshiwe abafanele bangene kunoma yiziphi izinhlelo zokubiyela noma ukuthola imikhiqizo yezimali (njengama-equity swaps, ama-cap, o-collar kanye neminye imikhiqizo yokuzibiyela) phezu kwemiKlomelo engabiyelwe futhi enomthelela wokuciphisa noma wokukhawulela ukuchayeka ezingcupheni ezihlobene nenani lasezimakethe zakwa-Brambles Securities.

## **2.5 Ukunikezwa Kwezinzuza Zokuvikeleka Kwamasheya akwa-Brambles**

Umuntu Ojutshiwe akufanele anikeze Inzuzu Yokuvikeleka nganoma yimaphi ama-Brambles Securities abanawo.

Isibonelo esijwayelekile sesimo le ndima engasebenza kusona yi-margin loan. Ngokuvamile, i-margin loan yile ngaphansi kwayo imali ibolekiselwa ukusiza umboleki akwazi ukuthola amasheya noma amanye ama-equity securities. Isivikelo saleyo malimboleko amasheya noma ama-equity securities athengwe futhi, kwesinye isikhathi, amanye amasheya abanjwa umboleki.

Ama-margin loan amaningi anikeza umbolekisi asuse amasheya aqondene nemalimboleko kwezinye izimo ngaphandle kokuthola imvume yalokho noma ukwazisa umboleki. Kwesinye isikhathi leli lungelo lingasetshenziswa isikhathi samahora angama-24 emva kokuvuka kwezimo ezichaziwe.

Uma Umuntu Ojutshiwe engathatha i-margin loan bese isivikelo salokho kubolekwa imali sibandakanyiwe kuma-Brambles Securities, umbolekisi angakwazi ukudayisa noma kungenjalo Ahwebe ngalawo ma-Securities. Lokhu kungabanjalo nangale kokuthi, ngesikhathi esifanele, kungaba Yinkathi Yokuvala noma Umuntu Ojutshiwe angathola ulwazi olubucayi oluhlobene nabakwa-Brambles ngokuvamile okungajwayelekile ukutholakala. Lokhu kungadala ukuthi Umuntu Ojutshiwe atholakale aphule le Nqubomgommo.

Yize noma ama-margin loan evamile ezimweni lapho ama-Security Interest esikhundleni samasheya akwa-Brambles enganikezwa, le ndima ikhulumha nganoma yiyiphi i-Security Interest phezu kwama-Brambles Securities. Abantu Abajutshiwe basengathola ama-Brambles Securities ngemajini noma enye imalimboleko yotshalomali uma ama-Brambles Securities engasetshenzisiwe njengesivikelo semalimboleko.

## **2.6 Ngingahweba nini ngama-Brambles Securities?**

Ukuphela kwesikhathi lapho Umuntu Ojutshiwe engaHweba khona ngama-Brambles Securities kulapho kungekho lwazi olubucayi olungavamile ukuba khona, noma ngabe Umuntu Ojutshiwe unalo noma cha ulwazi lolo.

Phezu kwalo mthetho ojwayelekile, Abantu Abajutshiwe abavunyelwe ukuHweba ku-Brambles Securities ngenkathi eqala ngosuku Iwesikhombisa ngaphambi kokuphela kwenkathi yokubika ngezezimali futhi ephela ngosuku lokuqala emva kwasaziso zokuqala semiphumela yesigcawu sengxene yonyaka noma yaminyaka yonke (okusho mhla zingama-24 kuZibandlela kuze kube osukwini olulodwa emva kokumenyezelwa kwemiphumela yaphakathi nonyaka maphakathi nenyanga kaNhlolanja kanye kusukela ngomhla zingama-23 kuNhlangulana kuze kube usuku olungenva kwestimemezelo semiphumela ephelele yonyaka ogcwele cishe maphakathi noNcwaba) (“**Closed Period**”).

Abakwa-Brambles bangasebenza lezi zinkathi lapho Abantu Abajutshiwe bengavunyelwe ukuhweba, ngenxa yowlazi olubucayi lungaba khona oluhlobene nodaba olungavamile ukutholakala. Lezi zinkathi zesikhashana, ndawonye neziNkathi ezivaliwe kubizwa ngokuthi ama-“**Prohibited Periods**”.

## 2.7 Imibandela emthethweni ojwayelekile

Le Nqubomgommo ayisebenzi ezimweni ezilandelayo:

- (a) utshalomali, Ukuhweba ngamayuniti, isikhwama noma esinye isikimu (ngale kwesikimu sotshalomali ku-Brambles Securities kuphela) lapho izimpahla zesikhwama noma esinye isikimu kutshalwe ngokwazi kwengxene yesithathu kuphela;
- (b) Ukuhweba ngaphansi kwesicelo noma isimemo esenziwe kubo bonke noma iningi labanikazi bakwa-Brambles Security, njengodaba Iwamalungelo, uhlelo lokuthenga isivikelo, uhlelo lokutshalwa kabusha kwenzozo yamasheya nokufinyelela okulinganayo ku-buy-back, lapho uhlelo okuyilo olunquma isikhathi sohlaka Iwesicelo sekugunyaziwe yiBhodi (Uhwebo olunjalo lubandakanya izinqumo ezhlobene nokuthi athathwe na amalungelo kanye nokudayiswa kwamalungelo okudingeka kuhlinzekwe ukuze kuthathwe ibhalansi yamalungelo ngaphansi kodaba lokulahlwa kwengxene engaphelele, i-pro rata);
- (c) Ukuhweba okuholela ekungabini khona shintsho enzalweni yomhlomuli kuma-securities (isib. ukudlulisa kwama-Brambles Securities asevele esesandleni Somuntu Ojutshiwe eya esikhwameni salowo Muntu Ojutshiwe noma esinye isikimu sokonga lapho Umuntu Ojutshiwe engumhlomuli khona);
- (d) lapho Umuntu Ojutshiwe eyi-trustee, Ukuhweba kuma-Brambles Securities yileyo traust, inqobo uma:
  - (i) umuntu Ojutshiwe engayena umhlomuli we-trust; futhi
  - (ii) noma yisiphi isinqumo sokuhweba ngesikhathi seNkathi Evinjelwe sithathwa amanye ama-trustee noma yizimenenja zotshalomali ngokuzimela ngaphandle koMuntu Ojutshiwe; kanye
  - (ii) umuntu Ojutshiwe engazange adalule Iwazi Iwangaphakathi kwamanye ama-trustees noma izimenenja zotshalomali.
- (e) uma Umuntu Ojutshiwe efisa ukuthatha isinyathelo sokwamukela, noma ukwamukela, isiphakamiso sokuqhubeke;
- (f) umsebenzi (kodwa hhayi ukudayiswa kwama-Brambles Securities kulandela umsebenzi lowo) woMklomelo, lapho usuku lokugcina lomsebenzi woMklomelo uwela eNkathini Evinjelwe, abakwa-Brambles bebesiNkathini Evinjelwe ende kakhlulu, noma bebe neziNkathi Ezivinjelwe zilandelana, futhi Umuntu Ojutshiwe ebengeke empeleni alindeleke ukuthi asebenzise Umklomelo ngesikhathi abekhululekile ukwenza njalo; noma
- (g) ukuhweba ngaphansi kwecebo elingadaluli lapho kuhlinzekiwe incwadi enika imvume kualndela indima 3.1 nalapho:
  - (i) Umuntu Ojutshiwe engazange angene ohlelweni noma ukuchibiyela uhlelo ngesikhathi seNkathi Evinjelwe; futhi;
  - (ii) icebo lokuhweba lingavumeli Umuntu Ojutshiwe asebenzise noma yiliphi ithonya noma ukubona kwakhe mayelana nokuthi kuhwetshwa kanjani, nini futhi kuyahwetshwa na. Umuntu Ojutshiwe ngeke akhansele icebo lokuhweba, ukukhansela noma ukushintsha imigomo yokuzibandakanya kwakhe ohlelweni lokuhweba, noma kungenjalo adale ukuthi icebo lokuhweba

likhanselwe noma lishintshwe ngesikhathi seNkathi Evinjelwe ngale kwezimo ezikhethekile, kulandela indima 3.2.

## **2.8 Izivumelwano Zobumfihlo nabeluleki bangaphandle**

Kungenzeka ukuthi, ngenxa yokumela noma ukweluleka abakwa-Brambles, abeluleki bangaphandle bakwa-Brambles bakwazi ukufinyelela ulwazi lwamanani olubucayi oluthinta ama-Brambles Securities.

Yize noma laba beluleki bangaphandle bengakhaviwe kule Nqubomgomo, kuyiNqubomgomo yakwa-Brambles ukucela ukuba abeluleki bangaphandle basayne isivumelwano sobumfihlo esikhulumha ngolwazi lwamanani olubucayi.

## **3. Izigunyazo Zokuhweba**

### **3.1 Ukuthola Isigunyazo**

Ngaphambi kokuba noma yimuphi Umuntu Ojutshiwe Ahwebe kuma-Brambles Securities, kufanelekuqala athole isigunyazo esivel:

- (a) kuSihlalo wakwa-Brambles (noma iPhini likaSihlalo noma Isikhulu EsiyiNhloko Ephezulu, lapho uSihlalo engatholakali), esimweni lapho izigunyazo zabaQondisi, noma yimuphi umuntu eseyekile ukuba uMqondisi Ophezulu kodwa engumsebenzi weQembu noma uNobhala WeNkampani;
- (b) iPhini likaSihlalo noma isiKhulu Esiphezulu EsiyiNhloko, uma kwenzeka kugunyaza uSihlalo; noma
- (c) uNobhala weNkampani, uma kwenzeka kugunyazwa noma yimuphi umsebenzi. Ngaphambi kokunikeza isigunyazo, uNobhala weNkampani uzofuna ukugunyazwa okuvela kuSihlalo noma omunye uMqondisi.

Lesi sibopho sisebenza ngaso sonke isikhathi.

Ukuze kugwenyewe ukuthandabuza, le nqubo yesigunyazo kufanele ilandelwe Abantu Abajutshiwe ngaphambi kokusebenzia Imiklomelo.

Abantu Abajutshiwe **akufanele** baHwebe kuma-Brambles Securities (kubandakanya ukusebenzia noma yimiphi imiklomelo) kuze kube ukugunyaza okudingekayo ngaphansi kwasigaba 3.1, kuyafakazelwa ngokubhaliwe (kubandakanya i-imeyli). Ukugunyaza kunganikwa noma kwenqatshwe ngokwazi kwabakwa-Brambles ngaphandle kokunikeza izizathu. Ukunqaba ukugunyaza isicelo sokuHweba kuma-Brambles Securities okougcina futhi kuyabophezelu kuMuntu Ojutshiwe ofuna isigunyazo.

Uma isigunyazo sinikeziwe:

- (d) Umuntu Ojutshiwe angaHweba ngokujwayelekile ezinsukwini ezimbili zomsebenzi emva kokuthola isigunyazo. Umuntu Ojutshiwe uyokwaziswa uma isimo semvume sishintsha kulezo zinsuku ezimbili zomsebenzi. Esinye isicelo kuzodingeka senziwe uma kungekho Kuhweba okwenzekayo ezinsukwini ezimbili zomsebenzi futhi Umuntu Ojutshiwe esafisa Ukuhweba; futhi
- (e) ngaphambi kokuhubeka nokuHweba, Umuntu Ojutshiwe ethola ulwazi lwamanani olubucayi nolungavamile ukutholakala, lowo muntu akufanele aqhubeke nokuHweba kungakhathaliseki ukuthi ubesegunyaziwe.

Abantu Abajutshiwe asebetshelwe ukuthi ngeke besakwazi ukuHweba akufanele batshela abanye abantu lokho.

### **3.2 Izigunyazo Zokuhweba NgeNkathi Evinjelwe**

Uma:

- (a) Umuntu Ojutshiwe esebunzimeni obukhulu bezezimali, njengoba kabaluliwe endimeni 3.3, noma kunezimo ezihlukile; njengoba kabaluliwe kundima 3.4 kanye
- (b) Umuntu Ojutshiwe lowo esho ukuthi akanalo ulwazi Iwamanani olubucayi nolungavamile ukutholakala,

isigunyazo singanikezwa umuntu ofanele ogunyazwe ngaphansi kwendima 3.1, ngokubona kwabo, ukuvumela lowo Muntu Ojutshiwe akwazi ukuhweba ngeNkathi Evinjelwe, kuncike emibandeleni efanayo naleyo yesigunyazo esinikezwe ngaphansi kwendima 3.1.

Umuntu Ojutshiwe efuna isigunyazo Sokuhweba kufanele enelise umu(aba)ntu ogunyaziwe ngaphansi kwendima 3.1 ukuthi usebunzimeni obukhulu noma ukuthi isimo sakhe empeleni sehlukile nokuthi ukudayisa okuhlongozwayo noma ukukhishwa kwama-Brambles Securities yisona sinyathelo esiphusile esitholakalayo.

Noma yisiphi isigunyazo esinjalo kufanele sitholakale kusengaphambilini. Asikwazi ukunikezwa emva kwalokho.

#### **3.3**

Umuntu Ojutshiwe angaba sebunzimeni obudlulele bezimali uma enesibopho sezimali esimcindezelayo esingeke sakwazi ukusombululeka ngaphandle kokudayisa ama-Brambles Securities. Isibonelo, isikweletu sentela kumuntu onjalo empeleni ngeke simenzele ubunzima obukhulu kwezezimali ngaphandle uma lowo muntu engenazo ezinye izindlela zokuqedo isikweletu.

#### **3.4**

Izimo ezikhethekile ezingabakhona uma:

- (a) Umuntu Ojutshiwe waphoqwa umyalelo wenkantolo, noma bekunezinquo eziyalelw yinkantolo (isib. udaba lomndeni) noma ezinye izimfuno zezomthetho noma zokulawula ezedlula ezinye zokudluliselwa kwama-Brambles Securities; noma
- (b) bekunezinye izimo uSihlalo wakwa-Brambles noma Isikhulu EsiyiNhloko Ephezulu (lapo uSihlalo ebandakanyekile) esizibone zikhethekile kakhulu.

### **4. Isaziso Zokuhweba**

#### **4.1**

Abaqondisi kudingeka bazise uNobhala weNkampani esikhathini **sezinsuku** ezimbili zomsebenzi emva kwanoma yiziphi izinguquko zezintshisekelo ze-Brambles Securities, noma izintshisekelo zanoma yibaphi abantu babo abasohlwini kundima 2.1(e) ngenhla.

Lokhu kusiza abakwa-Brambles bazise abe-ASX ngezinguquko zezintshisekelo, okufanele zenzeke ekupheleni kosuku lomsebenzi kulandela ukuthola isazizo.

Bonke abanye Abantu Abajutshiwe kudingeka bazise uNobhala weNkampani nganoma yikuphi ukuHweba kwe-Brambles Securities ezinsukwini ezinhlanu zomsebenzi zokuqlisa lokho kuHweba.

Amakhophi amafomu ezaziso ezifanele ayatholakala kuNobhala weNkampani.

#### **4.2**

Izaziso Zokuhweba ezinikezwé kulandela indima 4.1 kufanele zithunyelwe kuNobhala weNkampani ngokubhaliwe (kubandakanya i-imayeli).

### **5. Yini i-insider trading?**

#### **5.1 Ukuvinjelwa kwe-insider trading, kokuhweba kwabangaphakathi**

Ngamagama ajwayelekile, umuntu angaba necala le-insider trading uma:

- (a) Iwo muntu "unolwazi lwangaphakathi" - okusho ukuthi ulwazi ngokuvamile olungatholakali futhi, uma belutholakala ngokujwayelekile belunokwenza umehluko omkhulu enanini noma entengweni yama-Securities eNkampani. Ulwazi oluthatha njengolungaba nomthelela omkhulu uma belungaba, noma lungaba nomthelela esinqumweni sotshalomali kulabo abavame ukwenza utshalomali kuma-Securities, okusho ukuthi, ulwazi "lwamanani olubucayi"; futhi
- (b) Iwo muntu:
- (i) Uhweba ngama-Securities enkampanini;
  - (ii) ukhuthaza noma uthola omunye umuntu ahwebe kuma-Securities enkampanini;
  - (iii) ukuxhumana ngokuqondile noma ngokungaqondile lolo lwazi komunye umuntu lapho odlulisa umyalezo azi, noma kufanele ngabe uyazi, ukuthi othola Iwo myalezo kunamathuba okuthi uzoHweba kuma-Securities noma athole omunye ozoHweba kuma-Securities enkampani ("Tipping").

Kunezincazelo eziningiliziwe zemibandela okudingeka igcwaliswe ukuze ulwazi lumphase njengolutholakala ngojwayelekile. Ngenkathi izincazelo eziningiliziwe zibalulekile ekutholeni ukubambeka ngokomthetho, isimiso esivamile esiyisisekelo sibandakanya ukuthi, ukuze ulwazi lutholakale ngokuvamile, kufanele:

- lube nengxene ebonakala kalula; noma
- lube lumenyezelwe ku-ASX noma kungenjalo lwaziswe abatshalizimali abavame ukutshala izimali kuma-Securities; noma
- kungenjalo lubandakanye ukuncishiswa, iziphetho noma izizathu ezenziwe noma okufinyelelwé kuzona ngenxa yolwazi obekubhekiswe kulona emaphuzwini amabili angenhla.

#### **5.2 Izinhlawulo**

Ukuhweba kwabangaphakathi kuyicala.

Izinhlawulo zobugebengu bokwaphulwa kwezivimbalo zokuhweba kwabangaphakathi zibandakanya:

- (a) kumuntu ngamunye - inhlawulo engafinyelela kuma-\$765,000, nokubhadla ejele iminyaka efinyelela kwemihlanu; kanye
- (b) ibhizinisi - inhlawulo efinyelela kuma-\$7,650,000.

Lezi zinhlawulo zingezamanje ekubhalweni kwale nqubomgommo kodwa zingashintsha ekuhambeni kwasikhathi. Umhwebi ongaphakathi, kanye nanoma yibaphi abantu ababandakanya ekwaphulweni kwalo mthetho, nabo bangafanelo banxephezele izingxenye eziseceleni ngokulahlekelwa okube khona. Phezu kwalokho, i-Australian Securities and Investments Commission ingafuna izinhlawulo ezibhekiswe

kumhwebi ongaphakathi, nalapho kufanaleke khona, ingafuna umyalelo wenkantolo wokumuka lowo mhwebi wangaphakathi igunya lokuphatha ibhizinisi.

### **5.3 Izibonelo zolwazi lwamanani olubucayi**

Ukufanekisa isivimbalo esichazwe ngenhla, lokhu okulandelayo yizibonelo ezingenzeka zolwazi okungathi, uma lunikezwe umphakathi, luthathwe njengolwazi lwamanani olubucayi:

- (a) Abakwa-Brambles baphezu kwezinhlalo zokuthenga noma ukudayisa impahla;
- (b) inkinga yecala elikhulu elibhekene nabakwa-Brambles;
- (c) Izinguquko esimweni sezimali sakwa-Brambles seqiniso noma esingase senzeke noma ukuqhuba kwebhizinisi;
- (d) Izinguquko ezinkulu ezintsha ebhizinisini;
- (e) ithuba elikhulu lokuthola, ukulahlekelwa, yinkontileka enkulu noma isigunyazo ezivela kuhulumeni;
- (f) izinguquko ezhlongozwayo ezinzuzweni zamashaya noma izinguquko kunqubomgomo yezinzuzo zamashaya;
- (g) udaba olusha oluhlongozwayo lwamashey;
- (h) inguquko enkulu kuBhodi LabaQondisi noma obunye ubuholi obuphezulu;
- (i) uphenyo lokulawula noma ucwaningomabhuku; noma
- (j) ukwaphulwa komthetho okukhulu.

### **5.4 Ukubhekana nezingxenye eziseceleni**

Umuntu angaba necala lokuba umhwebi ongaphakathi malungana ne-Brambles Securities, yize noma kungeyena gaqa Ohweba kuma-Securities. Isivimbalo siwelela:

- (a) Ekuhwebeni kusetshenziswa abaqokiwe, ama-ejenti noma abanye okusetshenziswana nabo, njengamalungu omndeni, izikhwama zomcebo womndeni nezinkampani zomndeni; kanye
- (b) nokufunwa kwezingxenye eziseceleni ezizoHweba kuma-Brambles Securities, nokubandakanya ukunciphisa noma ukukhuthaza izingxenye eziseceleni ukuba Zihwebe.

### **5.5 Ulwazi noma ngabe lutholakale kanjani**

Akunandaba ukuthi umuntu uluthole kanjani noma kuphi ulwazi - akudingeki kuze kube uluthole ngaphakathi kwa-Brambles ukuze kube ulwazi lwangaphakathi.

### **5.6 Izikimu zamashaya abasebenzi**

Ukuvinjelwa kokuhweba kwabangaphakathi akubhekiseli:

- (a) izicelo zokuba; kanye
- (b) ukuzuzwa ngaphansi kwalezo zicelo,

i-Brambles Securities ngabasebenzi bakwa-Brambles noma nanoma yiziphi izinhlaka ezhlobene nebhizinisi ezenziwe ngaphansi kwamashey abasebenzi kanye nezinhlelo zezinketho.

Lokhu kuchaza ukuthi ukuvinjelwa kokuhweba kwabangaphakathi **ngeke** kusebenze ekuzuzweni kwanoma yibaphi abasebenzi bakwa-Brambles Securities ngaphansi kwanoma yimaphi amasheya abasebenzi bakwa-Brambles kanye nezinhlelo zezinketho (kubandakanya isicelo soma umsebenzi Wemiklomelo). Nokho, ukuvinjwa kokuhweba kwabangaphakathi **kuzosebenza** e-Australia kunoma yikuphi ukulahlwa okulandelayo yilabo basebenzi abanamashey kwa-Brambles azuzwe ngaphansi kwalelo sheya lomsebenzi nezinhlelo zezinketho.

Noma ngabe kuyasebenza ukuvinjwa kokuhweba kwabangaphakathi noma cha, imvume iyadingeka ngaphansi kwale Nqubomgomo ngokwenziwa kwanoma yimuphi umsebenzi Wabantu Abajutshiwe

bemiKlomelo phezu kwanoma yimaphi ama-Brambles Securities: bheka isigaba 3.

## **6. Uhwebo Iwama-Securities Nezinye izinkampani**

**Abaqondisi** kuchaza amalungu eBhodi.

**UMqondisi Ophezulu** kuchazaannoma yimuphi uMqondisi okhipha imiyalelo yokusebenza kubaphathi noma kubaholi be-Brambles.

**IQembu** lichaza abakwa-Brambles nezigungu zebhizinisi zakhona.

**Inkathi Evinjelwe** kuchaza:

- (a) noma iyiphi iNkathi Evaliwe; noma
- (b) izinkathi ezengeziwe lapho Abantu Abajutshiwe bengavunyelwe ukuhweba futhi eziyalelwangabakwa-Brambles ekuhambeni kwesikhathi lapho kungaba nolwazi olungelona olomphakathi olubucayi mayelana namanani okungenzeka ukuthi ngokujwayelekile alubi khona.

**Ama-Security Interest** achaza isibambiso, isifungiso, inhlawulo, isibambiso sempahla noma omunye umthwalo wesikweletu.

### **Izibopho Zempumelelo yale Nqubomgomo**

Ibhodi yakwa-Brambles inesibopho esiphelele ngale Nqubomgomo. INhloko Yophiko Lwezomthetho noNobhala WeQembu Lenkampani banesibopho sansukuzonke sokubhekelela le Nqubomgomo futhi kufanele iqinisekise ukuthi bonke abasebenzi bathola ukuqeleshwa njalonjalo futhi okufanelekile.

Inhloko Yophiko LwezoMthetho noNobhala WeQembu Lenkampani, ngokusebenziana neBhodi, izobukeza le nqubomgomo ngasohlangothini lwezomthetho kanye nokwenziwa komsebenzi okungenani kanye ngonyaka. Le Nqubomgomo ayiyona ingxene yenkontileka yabasebenzi, noma kungenjalo yensiwe, futhi ingachitshiyelwa ngokuhamba kwesikhathi. Abasebenzi bayamenya ukuba baphawule mayelana nale Nqubomgomo futhi baveze nezinye izindlela ezingasetshenziswa ukuze yensiwe ngcono. Amazwi okuphawula noma imibono kumele ibhekiswe kulowo Oyinhloko Yophiko LwezoMthetho noNobhala WeQembu Lenkampani.

Njengokusho kweNqubomgomo yakwa-Brambles i-Speak Up, akukho kuphindiselwa noma ukujeziswa okuzokwenzeka kumsebenzi ophakamise ukukhathazeka mayelana nale nqubomgomo. I-Brambles izibophezele ekuphenyeni, ukubhekana, kanye nokuphendula konke ukukhathazeka kwabasebenzi kanye nokuthatha izinyathelo ezifanele zokulungisa lokho okuphakanyiswe njengokuphulwa kwayo.
